1. Registration and Attendance:

- 1.1 All delegates must register for the conference through the official registration process.
- 1.2 Delegates partners are welcome to sat at an additional \$500 [includes accommodation and breakfast only].
- 1.3 Registration fees cover conference materials, access to sessions, and specified meals: [breakfast, lunch and dinner] as outlined in the conference programme.Delegates are welcome to stay at the venue before or after the event at their own costs and arranged directly with the hotel [Hilton Denarau].
- 1.4 Alcohol is NOT provided, and delegates are expected to drink responsibly.
- 1.5 Delegates are expected to attend all scheduled conference sessions, workshops, and events.

2. Travel Arrangements:
